NOTICE IS HEREBY GIVEN TO THE HUNTING FRATERNITY AND THE GENERAL PUBLIC THAT THE MINISTRY OF TOURISM THROUGH THE DEPARTMENT OF NATIONAL PARKS AND WILDLIFE (DNPW) INVITES APPLICATIONS FOR GRANTING OF HUNTING LICENCES IN THE FOLLOWING HUNTING BLOCKS FOUND IN GAME MANAGEMENT AREAS IN ZAMBIA.

PLEASE NOTE THAT:

1. SUCCESSFUL APPLICANTS ARE EXPECTED TO COMPLY AND HAVE PREVIOUSLY COMPLIED WITH THE PROVISIONS OF THE ZAMBIA WILDLIFE ACT NO. 14 OF 2015.
2. HUNTING FOR SUCCESSFUL CITIZEN, RESIDENT AND BONAFIDE APPLICANTS WILL COMMENCE AS SOON AS APPLICANTS ARE ISSUED THE LICENCE AND END ON 31ST DECEMBER 2024.

3. ALL APPLICANTS MUST BE ZAMBIANS OR ESTABLISHED RESIDENTS WHO ARE LICENCED FIREARM HOLDERS. A LIST OF SPECIFIED FIREARMS CAN BE OBTAINED AT THE DNPW OFFICES MENTIONED ABOVE.
4. ENDORSEMENTS WILL NOT BE ALLOWED DURING THE 2024 HUNTING SEASON.
5. BONAFIDE RESIDENT HUNTING LICENCES TO BE ISSUED TO APPLICANTS WHO ARE DOMICILED IN THE GMAS AND SHALL NOT BE TRANSFERABLE.
6. ALL APPLICANTS TO ATTACH CLEAR COPIES OF FIRST AND SECOND PAGES OF BLUE BOOK / FIREARM LICENCE (COVER PAGE AND CALIBRE PAGE).
7. ALL APPLICANTS TO ATTACH COPIES OF NRC OR RESIDENT PERMITS AND GRZ RECEIPTS AS PROOF OF PAYMENT FOR APPLICATION FORM.
8. THE USE OF FIREARM TRANSFER CERTIFICATES IS NOT ALLOWED.
9. THE USE OF **SHOTGUNS IS NOT ALLOWED** FOR WILD ANIMALS.
10. THERE WILL BE NO ISSUANCE OF DISTRICT LICENCES. LICENCES WILL ONLY BE ISSUED FOR SELECTED OPEN AREAS.
11. A MAXIMUM OF FIVE (5) APPLICATION FORMS SHALL BE ALLOWED PER PERSON AND ONLY ONE APPLICATION FORM SHALL BE ALLOWED PER HUNTING BLOCK FOR RAFFLE DRAW.
12. APPLICATION FORMS CAN BE PURCHASED AT K 200.00 AT DNPW DESIGNATED OFFICES EITHER BY CASH OR DEPOSIT INTO **ZANACO BANK ACCOUNT: DNPW-KWACHA HOLDING, GOVERNMENT COMPLEX BRANCH, ACCOUNT NO:5396091300218** AND THE ELECTRONIC DEPOSIT SLIP IN THE NAME OF THE APPLICANT SHALL BE PRESENTED TO THE CASHIER AS PROOF OF PAYMENT FOR THE APPLICATION FORM.
13. THE RAFFLE SELCTION METHOD SHALL BE USED FOR SELECTION OF CITIZEN, RESIDENT AND BONAFIDE HUNTERS.
14. ALL **SUCCESSFUL APPLICANTS** WILL BE REQUIRED TO PURCHASE THEIR HUNTING LICENSES USING THE **GOVERNMENT SERVICE BUS** BY LOGGING ONTO THE FOLLOWING ADDRESS <https://eservices.gov.zm>
 - Step 1. Log into your Zamportal account**
 - Step 2. Search for Department of National Parks and Wildlife under Service Provider and click apply filters**
 - Step 3. Click on Hunting License – Resident, and Apply**
 - Step 4. Fill in form and submit**
 - Step 5. Receive your invoice and pay**
 - Step 6. Print your Hunting License**
 - Step 7. Apply for the Permit to hunt in a GMA, and arrange with DNPW for hunting dates.**
